### 1.1 DESCRIPTION

The Tronair 08-4040-4010 Engine Compressor Washer is a portable unit with a 2-1/2 gallon capacity, designed to spray cleaning solution and/or clean, fresh water into jet and turbo prop engines.

The purpose of the engine compressor washer is to neutralize salts and acids collected in the engine by rinsing the engine's compressor section.

## 2.0 SAFETY INFORMATION

### 2.1 USAGE AND SAFETY INFORMATION

To insure safe operations please read the following statements and understand their meaning. Also refer to your equipment manufacturer's manual for other important safety information. This manual contains safety precautions which are explained below. Please read carefully.

### 2.2 SAFETY ISSUES



#### WARNING!

- **Never pressurize air tank more than 100 psi.**



#### CAUTION!

- **Use only clean water and/or engine cleaning fluids approved by engine manufacturer.**
- **Consult aircraft manual for correct procedure in performing engine wash.**

## 3.0 TRAINING

### 3.1 TRAINING REQUIREMENTS

The employer of the operator is responsible for providing a training program sufficient for the safe operation of the unit.

### 3.2 TRAINING PROGRAM

The employer provided operator training program should cover safety procedures concerning use of the unit in and around the intended aircraft at the intended aircraft servicing location.

### 3.3 OPERATOR TRAINING

The operator training should provide the required training for safe operation of the unit.

**NOTE: Maintenance and Trouble Shooting are to be performed by a skilled and trained technician.**

**4.0 PREPARATION AND OPERATION**

Follow engine manufacturer's recommendations for cleaning and rinsing engine(s). Use only engine manufacturer's approved fluids. Refer to label (V-1013) on unit. Nozzle is rated for ½ gal/min.

1. Ensure the tank is depressurized by depressing the tank handle prior to opening tank.
2. Fill with desired amount of fluid through fill connection.
3. Pressurize tank with shop air (100 psi Maximum).
4. Remove safety pin.
5. Connect hose assembly.
6. Depress tank handle to dispense pressurized fluid.

**5.0 MAINTENANCE**

1. Cleaning after each use  
Remove cleaning agents from tank after each use and empty tank as follows:
  - a. Invert tank (this saves the remaining fluid in the tank from being emptied).
  - b. Depress tank handle to discharge any remaining pressure left in the tank.
  - c. With tank de-pressurized, remove the tank discharge assembly.
  - d. Pour out any remaining fluid to be salvaged for future use.
  - e. Rinse out tank with clean fresh water.
  - f. Re-install the tank handle.
  - g. Disconnect hose assembly.
  - h. Drain hose assembly from coupling.
  - i. Re-install the hose assembly.
  - j. Pressurize tank to approximately 20 psi.
  - k. Blow out lines. Depress tank handle to run air through the unit.
  - l. Re-install safety pin.
2. Replace worn hoses as required.
3. Hydrostatically test tank as required due to physical damage; or as required by local law.
4. Perform the following prior to storage of Engine Compressor Washer:
  - a. Ensure fluid tanks are clean.
  - b. Clean the unit exterior prior to storage.
  - c. Cover unit and store in a clean, dry area.

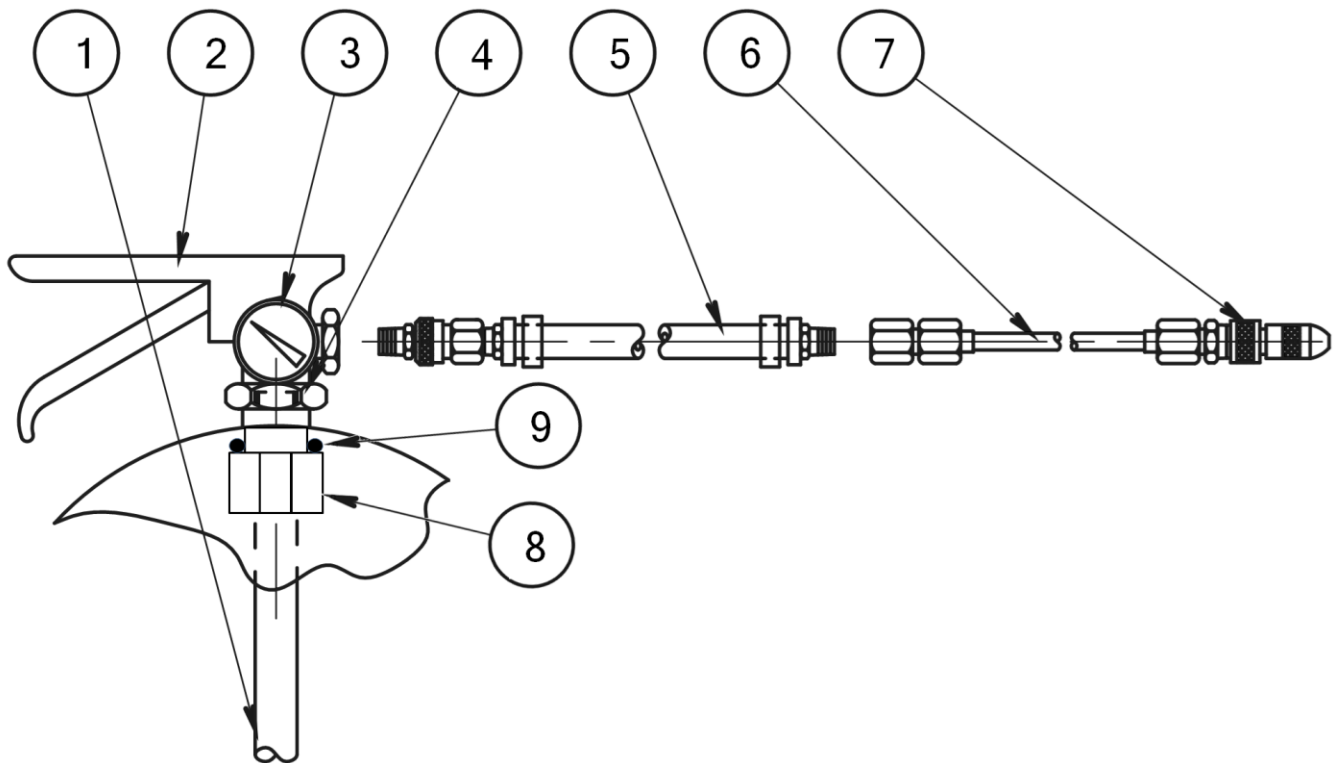
