To use your Reservoir Service Unit, follow the steps below:

- 1. Fill vessel with proper fluid.
- 2. Attach air supply hose to air valve.
- 3. Pressurize vessel to 85 psig maximum and remove air supply hose from air valve.
- 4. Transfer fluid by pressing trigger valve on hose end.

#### 5.0 GAURANTEES/LIMITATION OF LIABILITY

Any shipments to Tronair must be shipped freight prepaid. Freight costs on shipments to customers will be paid by Tronair on any warranty claims only. 
